	<p>age technology solutions, stocks forming part of eligible basic industries based on AMFI classification, as updated from time to time, that broadly represent manufacturing sector, as defined by the index provider of the benchmark index would form part of the theme.</p> <p>Additionally, the portfolio will be constructed on the basis of various broad factors such as prevailing market conditions, domestic and global economic scenarios, business and consumer sentiment, risk indicators, and a host of proprietary indicators (corporate, geopolitical, socio-cultural, economic, regulatory etc.) forming part of our Predictive Analytics suite. Coupled with our signature VLRT Framework, as our established risk mitigation tool, the data will be translated to put forth different scenarios that will highlight relevant stocks for portfolio construction.</p> <p>To achieve the investment objective, the scheme will invest in equity and equity linked instruments which invests into companies that are part of manufacturing theme across market capitalization viz. 



The statement of holding of the beneficiary account holder for units held in demat will be sent by the respective DPs periodically.

CAS for investors having Demat account:

- Investors having MF investments and holding securities in Demat account shall receive a single Consolidated Account Statement (CAS) from the Depository.
- Consolidation of account statement shall be done on the basis of Permanent Account Number (PAN). In case of multiple holding, it shall be PAN of the first holder and pattern of holding. The CAS shall be generated on a monthly basis.
- If there is any transaction in any of the Demat accounts of the investor or in any of his mutual fund folios, depositories shall send the CAS within ten days from the month end. In case, there is no transaction in any of the mutual fund folios and demat accounts then CAS with holding details shall be sent to the investor on half yearly basis.

- In case an investor has multiple accounts across two depositories, the depository with whom the account has been opened earlier will be the default depository.
- No Account Statements will be issued by the AMC to Unit holders who hold units in dematerialized mode. For Units in dematerialised mode, the Account Statements may be obtained by the Investor from the depository participants with whom the investor holds the DP account.

Annual Report or abridged summary thereof:

The mutual fund shall provide physical copy of the abridged summary of the Annual Report without any cost, if a request through any mode is received from a unitholder.
