While India aims to become the third-largest economy in the world, PSUs continue to be key drivers of economic growth and development. While PSUs have been key contributors to India's economic growth, it's important to note that their efficiency and performance can vary widely. Reform and modernization efforts are ongoing to enhance their competitiveness, operational efficiency, and accountability.</p> <p>Over the next five to ten years, as reforms continue to evolve, PSUs are poised to become stronger and more dynamic players across various sectors of the economy for the coming decades. Despite global trends favouring privatization, public enterprises continue to play a significant role in economic activities to varying extents. This fund seeks to invest in PSU stocks and leverage the potential value unlocked through disinvestment or divestment.</p> <p>The AMC may, from time to time, review and modify the Scheme's investment strategy if such changes are considered to be in the best interests of the unit holders and if market conditions warrant it.
